  - 2. A declaration that the second defendant is obliged, having regard to the provisions in the Federal Constitution referred to above, to set up a care-taker government during the period Parliament is dissolved until the swearing in of the new cabinet after the general election for the purpose of only attending to day-to-day administration of government during this period without any power to decide on policy matters, allocation of public funds or use of public facilities during the campaign in the forthcoming general election;
- 3. Costs; and
- 4. Any further order or relief deemed fit and proper by this Honourable Court.

In the event the defendants do not enter an appearance, judgment or any order of the Court may given as the Court thinks fit and proper. Dated this 4<sup>th</sup> day of February, 2008.
